Consent to the processing of personal data

Your personal data will not be disclosed by us; they may be communicated to public authorities only if required by law, or to other organizations that collaborate with us in the provision of the service. Your data will be retained for the period required for the provision of the service and in any case no longer than 5 years. Your data will not be disseminated in non-EU countries. Your contact details may also be used exclusively to inform you about our services and social initiatives. In the management of your personal data, your rights will be taken into account (articles 15 to 22 of Regulation 2016/679), namely the right to access, rectification, and erasure (right to be forgotten), restriction of processing, objection to processing, the right to lodge a complaint with the Privacy Guarantor. Right of withdrawal
