Consent to the processing of personal data

Right of withdrawal

Pursuant to Articles 49-59 of Legislative Decree September 6, 2005, n. 206 (the Consumer Code), the purchaser has the right to exercise the right of withdrawal within 14 (fourteen) days from making the payment. Exercising this right does not require providing any reason, nor does it incur any costs, except for the administrative fees arising from the refund of the amount paid, which are quantified at € 10,00.
